

ANNOUNCEMENT

PRELIMINARY RESULTS OF CHONGQING GAS FOR THE YEAR ENDED 31 DECEMBER 2023

On 4 March 2024, Chongqing Gas released its preliminary results for the year ended 31 December 2023.

Chongqing Gas Group Corporation Ltd.* (重慶燃氣集團股份有限公司) ("Chongqing Gas") is a company incorporated in the People's Republic of China. The shares of Chongqing Gas are listed on the Shanghai Stock Exchange. As of the date of this announcement, Chongqing Gas is indirectly owned as to 39.17% by China Resources Gas Group Limited (the "Company" and together with its subsidiaries, the "Group") and is a subsidiary of the Company.

On 4 March 2024, Chongqing Gas released its preliminary results (the "**Chongqing Gas Preliminary Results**") for the year ended 31 December 2023 (the "**Reporting Period**"). Set out below are the key financial information of Chongqing Gas Unaudited Financials:

II. EXPLANATION OF OPERATING RESULTS AND FINANCIAL STATUS

During the Reporting Period, the Company achieved a gas sales volume of 3.496 billion cubic meters, representing a year-on-year increase of 24 million cubic meters or 0.69%. Among which, ① the financial gas sales volume for purchase and sales was 3.390 billion cubic meters, representing a year-on-year increase of 128 million cubic meters or 3.94%; ② the pipeline gas transmission sales volume was 106 million cubic meters, representing a year-on-year of 48.80\%. During the Reporting Period, the Company completed financial settlement for 255,600 gas installation customers, serving a total of 5,846,400 customers at the end of the year.

During the Reporting Period, the Company achieved revenue of RMB10.247 billion, representing a year-on-year increase of 17.26%; net profit attributable to shareholders of the Company amounted to RMB493 million, representing a year-on-year decrease of 22.79%.

The Chongqing Gas Unaudited Financials have been prepared in accordance with the PRC Generally Accepted Accounting Principles, have not been reviewed or audited by the Company's auditors, and may require adjustment during the course of auditing. The financial information is limited to Chongqing Gas only and does not represent or provide a complete view of the operational or financial status of the Group. Shareholders and potential investors should exercise caution when dealing in securities of the Company and should not rely solely on such information.
